Rules and Regulations for Wineries Lubbock Uncorked: April 1, 2023 1 p.m. to 6 p.m.

Location: American Windmill Museum, 1701 Canyon Lake Drive, Lubbock, Texas

One (1) 6' table, covered and draped & One (1) 6' table for you to cover.

Two (2) folding chairs.

- Four (4) Name Badges (Lanyards) with 5 complimentary drink tickets for staff working the event (workers will need to get wrist banded to consume alcohol)
- Dump bucket, water pitcher, corkscrew (if needed), cooler and ice (please bring your own pouring spouts)
- Marketing through Chamber website, social media by the Chamber and Visit Lubbock.
- Security throughout the event
- Ability to sell bottled wine, wine club memberships, or winery merchandise to attendees

**Temporary Event - Each winery will need to have a festival permit to sell wine by the bottle to attendees at this event unless your wine is being provided by your distributor. Please send a copy of your festival permit to the Chamber via email to sydney.tipton@lubbockbiz.org or by fax 806-761-7013.

Participants (called Exhibitors) in Uncorked must agree to all of the following:

Payment to Wineries: Attendees will give you tickets for wine tastings. One ticket = one (1) ounce pour, 5 tickets = a glass (5) ounce pour. The Chamber will pay 50 cents per ticket and will mail that payment by check after the event. You may sell wine by the bottle to the public from your booth. Please bring signage to promote the fact that you have wine available to purchase and to encourage bottle sales. The Chamber does not take a percentage from your bottle sales. Please note you are only to sell sealed bottles of wine, not glasses of wine.

Exhibitors shall not injure, mark, paint, or deface the exhibit area in any manner. The vendor is liable for any and all damage that may be caused to the building or other property in connection with their exhibit. Vendor agrees to keep exhibit area clean during the show and will remove all debris and exhibit materials after the show and dumped in the trash bins outside.

The Chamber reserves the right to decline or prohibit the participation of any vendor, which in its opinion is not in keeping with the character of the general exhibits and purpose of the show; this includes personal conduct, clothing or costumes, printed material, video or audio presentations, souvenirs or anything that is, in the opinion of show management,

undesirable, objectionable, or inappropriate.

The vendor agrees to pour one-ounce tastings in exchange for one ticket and a five ounce pour in exchange for five tickets. Wineries will be reimbursed at a rate of 50 cents per ticket that they receive from the public. The chamber will count tickets and reimburse the vendor for the tickets that are turned in at the end of the night.

Exhibitors agree to accept the assignment of the space from Chamber staff and understand that vendors are not permitted to sublet any portion of their space without prior approval from the Chamber. The Chamber reserves the right to relocate vendors/booths or modify the floor plan should it be deemed necessary at any time. Vendor assignments will be made within 72 hours of the event.

Exhibitor agrees to indemnify and hold harmless the Lubbock Chamber of Commerce and all of its owners, officers, affiliates and

subsidiary companies and all of their owners, officers, affiliates and subsidiary companies against any and all losses, damages, expense, cost, charge, liability, claims and demands occurring to, resulting from, or connected with our exhibit, and/or demonstration, and/or presentations. Sponsor/Owner Companies, their officers, and all affiliates and subsidiary companies shall have no liability to an exhibitor if the sponsor(s) postpones or cancels the 2022 Lubbock Uncorked because of Acts of God, accident, fires, or interruptions of whatever nature beyond the sponsor's control.

Sponsor/Owner Companies, officers, and all affiliates and subsidiary companies assume no responsibility for the safekeeping of any property used with our exhibit, and/or demonstration, and/or presentation, and we acknowledge that such property is solely our responsibility.

We hereby warrant and represent that we will maintain a comprehensive general liability insurance policy with limits of not less than \$1,000,000 (One Million Dollars) for all bodily injury and damage arising out of a single occurrence, including coverage for the indemnity and hold harmless herein.
