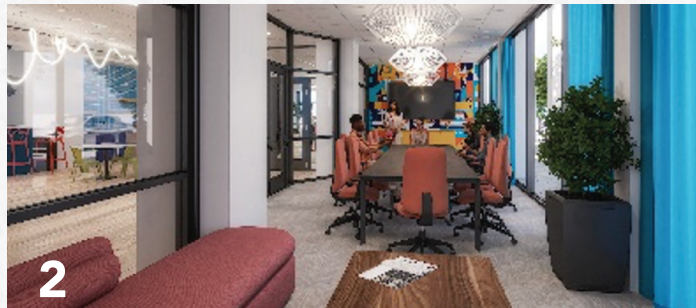

Bids accepted May 29-June 16

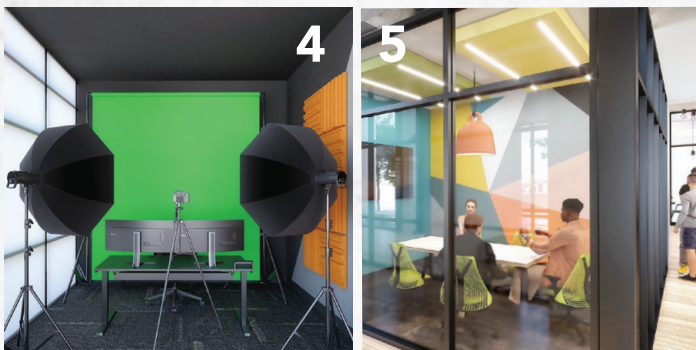
- Naming rights to board room for 10 years.
